Our subcommittee did not meet on Monday September 2nd because of the storm. It was rescheduled until September 9th. Last month met with 32 members in attendance. As of our current roster we bring in 35 presentations to 13 different facilities. We have 4 open commitments...Monday, Imperium at 7:00 pm, Friday Paul Rein at 7:00 pm, Legacy Healing Saturday at 7:00 pm, and Imperium Saturday at 7:00 pm. The new business is we had donations of 9 JFTs, 5 step working guides and 9 miniature basic texts from Noontime Recovery which the committee decided to distribute in the jails, BARC facilities, and other DOC receiving facilities such as Banyan and Stepping Stones. Region H&I August 2019-Member Deana R. attended South Florida Region and brought this report to members. - The person who was voted to be Vice Chair of South Florida Region H&I had to step down and Leo from the Keys was nominated but there was not enough group representation (we did not meet quorum) to vote. There was no other information from Region H&I.
