Greetings from Gold Coast, I'm an addict called Chris C.,

We last met on 8/11 at Serenity by the Sea Clubhouse. There were 50 of 59 groups present on our roster. We're having great response by the participating groups and have started to modify Open Forum to account for any groups to make announcements as well as non-group affiliated members to participate. Previously it was simply any member or new participant. By modifying the process we're following our policy as was written. Our policy manual is now being modified every ASC with voted policy changes as opposed to twice a year which was cumbersome in the past.

The Gold Coast Anniversary Dinner August 3<sup>rd</sup> was a success. We ran into an issue with a South Broward function that was occurring the same evening. Discussion ensued regarding the utilization of the Region's Calendar in order to not run into this next year, although this has happened in the past which of course happens when no one is checking the calendar. In the future our Activities Subcommittee plans on stressing the importance of checking the Regional colander and more importantly training the incoming Chair positions to do so as well.

We have a new Area History & Research Ad Hoc chaired by yours truly. This was formed after trying to locate documentation for the Anniversary Dinner, finding that the most up to date (and only) document was from 2007, that's one year before I got clean. There's a tremendous gap in our South Florida Area history in 1978 through 2007 when the document was created.

I'm being tasked along with volunteers from the Ad Hoc to gather any and everything that we can get our hands on. We're leaning towards scanning the information/documentation as the last thing we need is an analogue stockpile of documents. I learned from one member that we had historical documents at one point after he got clean and that it was somehow lost after the storage facility wasn't paid for. That's somewhere in the past 15-20 years. It's 2019, digital works just fine with us. Currently the idea is to have one of us come to wherever the information is and scan it.

I'm asking everyone here to start checking with members who have documentation regarding events, minutes from group meetings/ASC/RSC meetings, flyers, meeting lists, even photos of events. This is going to be a large task and I expect it to take some time to complete. Recorded statements also have the potential for not only this generation, but also following generations of addicts to be able to know where they come from.

Expect a flyer for the next RSC with contact information once we get the Ad Hoc together for planning and implementation.

I'd to introduce Gold Coast's new Alt. RCM, Deana. She has some things to report on as well:  
Inter Deana's stuff here:

My name is Deana, alternate RCM for Gold Coast Area. The Inmate Step Writing Guide (ISWG) subcommittee met this last month. The committee has been reaching out to DOC facilities all over Florida and has gotten this service approved in 5 facilities. We have secured a PO Box that is active until 10-31. We have been checking the PO Box and have not received any letters from inmates. The secretary is sending a follow-up letter, PowerPoint presentation & flyers to the 5 facilities that have agreed to introduce the ISWG program. I also brought copies of the PowerPoint presentation, flyers & facility contact list to Region/H&I for support. The ISWG chair will plan to visit local facilities to introduce the program. We have another member that has volunteered to manage a sponsor/sponsee spread sheet once we get inmates writing. This ad hoc committee is now seeking ways of marketing this service to the inmates so we can begin to be of service. Since the Region H&I meeting on Saturday, I have been connected with Florida Region member Colin who appeared eager to learn more about how we have developed this service. I forwarded him our policy and guidelines handbook, along with flyer, PowerPoint, and list of approved facilities. He seemed confident he would be able to reach out to NA members involved in Behind the Walls that currently go into the ISWG approved facilities and ask that they also begin educating the inmates about this new NA service. Another suggestion I will be taking back to the ad hoc committee is the idea of making the flyer more visual (i.e. larger font, bolder, brighter, etc.). We will continue to keep the Region updated on the development of the ISWG ad hoc committee. Thank you for letting me be of service.

Greetings trusted servants,

All is well with insurance, several groups and events have requested certificates. all have been handled.

The other thing that came down the pike over the last cycle was the Draft proposal for changes to the FIPT and it's accompanying bulletins. Although what has been sent out was only an R&I proposal the main points are:

Operational rules:

Requiring a CAR Motion and 2/3 of the WSC voting in favor to have an inspection.

Housekeeping of language, delegate instead of representative, changing description of WSC committee's to more accurate describe current practices, adding the word "The" in places deemed appropriate.

Bulletin 1: Use policy

1. Changing the reproduction of recovery literature allowed by groups by adding current, removing book length pieces, and clarifying that this does not include any permission for electronic or on line formats.
2. Rewriting the introduction and moving the section on copyright ahead of trademarks.
3. Using the term policy throughout the document, rather than a mix of policy and guidelines.

Changes to the trust itself:

This is a much longer and more detailed process. It requires a CAR motion to initiate, and a second CAR motion to approve the changes. Expect a CAR motion to create a work group, and a final product in the 2022 CAR. Some things they've already identified and expect to be included:

Inclusion of Zonal Delegates, right now it only allows regional delegate votes. We now do also seat Zones so they expect them to be added to the voting process.

I will be doing a workshop at the October region in Shark Coast from 1pm-3pm to review this information more fully, keeping in mind that there will be motions in the CAR that may be different from the information available now. But this will be a good chance to start the discussion and gather a better idea of the conscience, or feeling, of the region on these matters. RCM's will likely know the members that have an interest in this topic, please be sure to make them aware of the workshop. It will be a much better workshop if we are able to solicit a wide range of feelings on this. The more information, and different perspectives we can gather the better we can come to understand our true conscience on this.

Hello all! This is the first meeting of Additional Needs with Outreach since the Regional approval to move the position from PR to Outreach.

A quick recap of what the Additional Needs POC does:

Assists groups, Areas and Region, upon request, with accessibility issues relating to those with physical, vision and hearing disabilities as well as with service dog issues. In addition, issues relating to bringing the message to old timers with disabilities and newly addicted seniors are addressed. This is accomplished by balancing U.S and state laws with the Traditions and spirituality of the program. Additionally, the POC helps resolve any ADA (American Disabilities Act) complaints, preventing any further actions that could adversely affect the service bodies, or NA as a whole. Situations that occur are resolved in writing and on file with Region.

This is accomplished by workshops, going to groups/areas that request assistance, contact by email or phone and creating guidelines to assist the groups and areas.

An important note to bring up: since there have been many changes in the last years with service representation, the original guidance on the guidelines has been forgotten. The plan has been that any guidelines, and approved on the Region floor, would be placed on the Region website in the Additional Needs folder as a resource. When all the guidelines were completed, the plan was to present the whole packet to the Areas for approval to place in the Regional Guidelines as an Appendix. It was never intended to vote each and every guideline separately, nor placing a guideline individually on the website. I believe there was a confusion at the June Region as to the procedure previously determined.

Also, we at SFR have set the bar on accessibility! NAWS has previously requested a copy of all our guideline resources and has been quite impressed!

A side benefit on the confusion was that a group GSR and several Area trusted servants did reach out to ask questions. Previously, many Areas and groups did not receive the guideline information and therefore were struggling with issues that had been addressed.

I personally am also the chairperson of the SEZF PR Additional Needs Workgroup. This workgroup has presented a workshop at the Florida Service Symposium as well as beginning to interpret NA literature to ASL and examination of NAWS website for accessibility for the blind.

Using the workgroup, we have just completed a guideline for the Blind and Vision Impaired. It is submitted in this report for review by Region and to add, as a resource, to the Region website Additional Needs folder. Please do share this guideline with the groups.

I thank those that have already sent me the survey results and ask that the rest of the Areas please do so. This was the survey asking about the number of blind, deaf and physically disabled members in the areas. This information will aid in the creation of Outreach guidelines for those who are blind and deaf, especially in the schools for the blind and deaf as well as continuing to aid reaching out to those with physical disabilities that are confined in their ability to reach a physical meeting.

Also planned is a guideline on Conventions, Conferences and Events. I am hoping that all guidelines needed will be completed within the next 6 months.

I also request a motion to fund my hotel at the next Region.
